TERMS AND CONDITIONS

1. I acknowledge that the Freshwater & District Horse & Pony Club (FDHPC) may vary the agistment rates upon giving 14 days notice in writing.
2. I acknowledge that agistment fees are due and payable in advance every four weeks within 14 days of receipt of the agistment invoice. The FDHPC may charge a monthly accounting fee on overdue accounts.
3. I acknowledge that the FDHPC relies on the information provided by me and I state that all the information is accurate and complete.
4. I acknowledge that I agist my horse at the grounds at my own risk and that I am aware that activities involving horses can be hazardous and that the servants, agents, representatives or volunteers accept no responsibility or liability for any injury or loss that I or my horse might sustain as a direct or indirect consequence of agisting whether such injury is a consequence of any act or omission by the servants, agents, representatives or volunteers. except in regard to any rights they may have arising under the Trade Practices Act 1974.
5. I agree that I will obey and will comply with all rules and/or directions made or given by the F&DH&PC in connection with the agisting of horses. In particular I acknowledge that I have been advised to wear an approved helmet at all times whilst riding and appropriate footwear when handling and/or riding my horse.
6. I accept all risks associated with the agistment of my horse, including the possibility of injury, death, loss or damage to myself and/or my horse.
7. I agree to indemnify the F&DH&PC against all claims made by any other person against the FDHPC in respect of any injury, loss or damage suffered by myself, my horse or by any person or their horse arising from or in connection with the my agisting/riding activities, whether such injury, loss or damage was caused directly or indirectly by any action of the FDHPC.
8. I hereby release the FDHPC from all such claims, and indemnify the FDHPC against all claims made by or on behalf of any other person.
9. I acknowledge that I must report all accidents, injuries, loss or damage to the FDHPC when I become aware of them.
10. If I suffer any injury or illness whilst at the grounds, I agree that the FDHPC may provide evacuation, first aid and medical treatment at my expense, and my acceptance of these terms and conditions constitutes my consent to such evacuation, first aid/or medical treatment.
11. If my horse suffers any injury or illness at the grounds and I am unable to be contacted, I agree that the FDHPC may provide evacuation, first aid and medical treatment at my expense, and my acceptance of these terms and conditions constitutes my consent to such evacuation, first aid/or medical treatment.
